Defense of physician under allegations of improper treatment of patient for suicide

#### Bank Fraud & Environmental Crime

Owner (debtor) created multiple fictitious companies to defraud more than 25 financial institutions throughout the Southeast and Midwest. Plaintiff was sentenced to 73 months for bank fraud and 60 months for storing hazardous wastes without a permit. Represented financial institution pursuing debtor in bankruptcy court.

Freight damage- (Carmack amendment) involved 20 truckloads of machinery and transported to central Mexico from Alabama. Allegations of faulty cargo securing. Allegations of cargo damaged during transport. Depositions across the southeast and Mexico. Multimillion dollar damage claim. Low six-figure settlement. Defended trucking company.

Motor vehicle accident- pedestrian fatality- our driver ran over an elderly gentleman who had eloped from an assisted living facility. He was lying in the middle of the road at about 10 PM. Case settled once it was determined driver was not medically qualified to drive. Defended trucking company.

Motor vehicle accident-injured adverse driver, broken neck-our driver's truck became an operable and was part parallel to the roadway by the side of the road. Motorist pulled out onto the highway from the front of our truck. The injured driver was coming up the highway and did not see the motorist pull out until too late. The collision ensued. Case is still ongoing. Defending disabled truck company, direct assignment.

Motor vehicle accident-lowboy trailer struck astride railroad tracks- handle action regarding lowboy trailer pulled across railroad tracks at a stop sign crossing. The train struck the lowboy in the middle. The trailer was empty. Damage to truck, trailer and train. Amazingly, property damage only. Represented railroad company.

Freight falling damage- Personal injury to dock worker- opened trailer doors and cargo fell on his head, resulting in multiple neck surgeries. Complex relationship to deal with Worker's Comp line and trucking company and shipper/loader. Represented carrier.

Transportation cases -long-term representation of Class I railroad including defense of dozens of FELA claims. Also defense of numerous crossing accidents and trespasser incidents. Scope of injuries range from neck and back surgeries to amputations to paraplegia to multiple fatalities.
